# Code of Conduct For Employees

Our Code of Conduct outlines our ethical guidelines for three key areas of sustainability: social, environmental, and ethical. We all share the responsibility of creating a workplace and organization shaped by sustainability, respect, and integrity. These guidelines define the principles and values that guide our actions and ensure we contribute to positive impact both within and beyond our organization.



## 1. Social Sustainability Global Compact goal 8 och 10

We aim to foster an inclusive, fair, and respectful work environment where everyone is treated with dignity, regardless of gender, age, ethnicity, religion, sexual orientation, disability, or other personal characteristics.

#### Equality, inclusion, and equal treatment

We promote diversity and work to ensure all employees have equal opportunities, regardless of their background. We strongly oppose all forms of harassment, discrimination, or unfair treatment. At Nitton93, we follow our official Equal Treatment Plan.

#### Working conditions

We are committed to reducing our carbon footprint and actively work to implement climate-friendly solutions across all areas of our business. Through the Science Based Targets initiative (SBTi), we have committed to reducing emissions within Scope 1 and Scope 2 by 42% by 2030.

We aim to work with suppliers and partners who share our values on environmental responsibility and sustainability. We prioritize eco-friendly products and services in our purchasing. Each year, we send out a self-assessment form to all our subcontractors, where they are asked to answer key questions about materials and production. This helps us ensure sustainable sourcing and avoid materials from vulnerable regions. The responses generate a risk assessment for each supplier within the broader ESG scope. As a company, Nitton93 also regularly visits suppliers to ensure our standards are met.

#### Innovation for the environment

We encourage innovation and initiatives that support sustainability, such as developing new and more environmentally friendly products and services. Our in-house TripleC methodology helps customers and partners make better environmental decisions by looking at the interaction between the three C's: Cost, Concept, and Carbon.
